

04 Officials

4.1 General

- 4.1.1 With the exception of guest judges for artistic competitions, all officials must be members of ACTISA, another State Association or APSA.
- 4.1.2 Officials are roles as defined by ISA and the ISU and includes trial officials and any additional roles as required by ACTISA.
- 4.1.3 All ACTISA Officials are required to follow all applicable regulations, policies and codes of conduct endorsed by ACTISA, ISA and the ISU.
- 4.1.4 All ACTISA Judges are required to accumulate update points as per Appendix C. Records will be maintained by the ACTISA Judging Convener but may also be kept by the individual Judge.
- 4.1.5 ACTISA Officials are encouraged to serve at interstate tests, competitions and championships however approval must be given by ACTISA first
- 4.1.6 Any ACTISA endorsed Judge, Trial Judge or Technical Official operating exclusively as a volunteer may claim reimbursement of travel to and from duties both locally and interstate. They may also claim for accommodation and registration fees for interstate events. ACTISA Officials may submit claims in writing with receipts attached, for expenses incurred while on judging duties interstate. The amount of reimbursement will be determined by the ACTISA Council upon receipt of the claim.

4.2 Minimum Ages for Judging

Minimum age to Trial Judge Aussie Skate Tests, Competitions and	15 years
Club Competitions.	10 yours
Minimum age to Judge Aussie Skate Tests, Competitions and Club	16 years
Competitions	10 years
Minimum age to Trial Judge National Tests, Interstate Competitions	16 years
and Championships	10 years
Minimum age to Judge National Tests, Interstate Competitions and	18 years
Championships	10 years

4.3 Promotions

4.3.1 Prior to promotion at National level, Judges must have trial judged a minimum number of tests and competitions at a satisfactory standard. The minimum number of tests is outlined in Appendix C, but may be less, at the discretion of the Judging Convener and approval of the Council. The number of competitions is not set and promotions will be based on results and experience.



- 4.3.2 Aussie Skate test promotions are subject to satisfactory completion of sufficient Aussie Skate tests at all levels over a minimum period of three months. Depending on experience, initial promotions may be for only part of the curriculum. Requirements may be waived at the discretion of the Judging Convener based on the judge's own skating experience in these areas.
- 4.3.3 All promotions are to go through the Judging Convener who is responsible for their tabling at the next Council meeting. The Council must approve all promotions.

4.4 Removal of Officials

Officials may be demoted or removed from the ACTISA Officials panel for the following reasons:

- A Breach of any of 4.1.3.
- B A significant period of inactivity.
- C At the request of the Official.
- D Non payment of Membership fees.

4.5 Reinstatement of Officials

Upon application by the Official, ACTISA may reinstate the Official on the Panel but not necessarily at the level previously attained.

4.6 Interstate Officials

- 4.6.1 Interstate Officials may be invited to serve at any ACTISA test, competition or championship and must be on their State's list of officials.
- 4.6.2 Interstate Officials may be reimbursed for expenses up to an amount determined by ACTISA.
