



## **06 Funding**

### **6.1 Grants**

- 6.1.1 Affiliated clubs, ACTISA members and ACTISA may apply for grants from organisations whose ethics and objectives do not conflict with those of ACTISA, ISA or the ISU.
- 6.1.2 Affiliated clubs and ACTISA members are required to submit all grant applications to ACTISA for endorsement.
- 6.1.3 All applications will be considered at a Council meeting.
- 6.1.4 In exceptional circumstances members of the ACTISA executive may submit an application on behalf of ACTISA. This application must be ratified at the next Council meeting.
- 6.1.5 If necessary, ACTISA will rank grant applications.
- 6.1.6 Applications from coaches that require ACTISA endorsement will only be considered if they do not conflict with an application from a skater.

### **6.2 Sponsorships**

- 6.2.1 Affiliated clubs, ACTISA members and ACTISA may accept sponsorship from organisations whose ethics and objectives do not conflict with those of ACTISA, ISA or the ISU.
- 6.2.2 Affiliated clubs and ACTISA members are required to seek approval from ACTISA prior to accepting any sponsorship.
- 6.2.3 All applications will be considered at a Council meeting.
- 6.2.4 In exceptional circumstances members of the ACTISA executive may approve a sponsorship on behalf of ACTISA. This approval must be ratified at the next Council meeting.
- 6.2.5 Any conditions of sponsorship must not conflict with the constitution, regulations, policies or objectives of ACTISA, ISA or the ISU.

### **6.3 Fundraising**

- 6.3.1 Affiliated clubs, ACTISA members and ACTISA may participate in any fundraising activities that do not conflict with the ethics and objectives of ACTISA, ISA or the ISU.



- 6.3.2 Affiliated clubs and ACTISA members are required to seek approval from ACTISA prior to any fundraising activity where the sport of figure skating is advertised by any means including posters, photographs or clothing.
- 6.3.3 Affiliated clubs and ACTISA members are not required to give ACTISA any proceeds from their fundraising.
- 6.3.4 Unless approval is given, any money earned by any means as fundraising for ACTISA must be properly acquitted and paid in full into the ACTISA account prior to the deduction of any expenses.
- 6.3.5 Expenditure to purchase items for any fundraising activity must have the prior approval of the Council.
- 6.3.6 Fundraising money shall be for the benefit of as many skating members as possible and the Council shall have the final say how it is used.

## **6.4 Donations**

- 6.4.1 Donations may include but are not limited to money, goods, services and vouchers.
- 6.4.2 Affiliated clubs, ACTISA members and ACTISA may accept donations from any organisation or individual whose ethics and objectives do not conflict with the ethics and objectives of ACTISA, ISA or the ISU.
- 6.4.3 Any conditions of donation must not conflict with the constitution, regulations, policies or objectives of ACTISA, ISA or the ISU.
- 6.4.4 Unless a specific purpose is defined by the donor, donations shall be for the benefit of as many skating members as possible and the Council shall have the final say how they are used.
