Applicants requesting more than one test on the same test day must discuss this with the ISA Test Convenor prior to submitting their forms and payments.

ACTISA will not accept late applications unless:

- time permits (applications will be processed in order of receipt), *and*
- qualified judges are already on the panel.

At the time of application, skaters must be current financial members of ACTISA or another State Association. Members of another State must have written permission to test in ACT.
